CHAIR MESSAGE - TRAINING/CEO APPOINTMENT

These last 12 months have been very challenging for Floor NZ / ATI, especially with the sad passing of our CEO, Kari Pearcey earlier in the year. Our small team really stood up and took on the challenge of filling that void all whilst maintaining the high training standards necessary. The Board and I would like to acknowledge Jeff Henry's contribution in taking on the Acting CEO role during this very difficult time whilst we were juggling a lot of balls.

On top of business as usual we were trying to orchestrate a transition to take on all the Flooring training functions from BCITO. After many meetings with different Government organisations and costs incurred along the way, it was clear for the Board that there was uncertainty around the success of delivering the change and the costs to implement the transition would be something that we could not absorb without significant influx of funds and no guarantees. It was decided that we should consider an alternative approach, and we engaged with BCITO Te Pūkenga on working through the opportunities we believe exist for improving training participation, promotion, and quality and how we might work better together to deliver on those opportunities.

We are pleased to announce that we believe we are very close to having a much better go forward for training for the flooring sector. We have a new agreement for the ATI to provide block course training in 2024 and more importantly a nearly finalised Collaboration Agreement with the BCITO Te Pūkenga where we will work together to improve training participation, promotion, and quality. We will update membership further on this in 2024.

Now that there is a clearer vision for Floor NZ and the ATI, we are very pleased to formally announce that Jeff Henry has accepted the role of CEO for Floor NZ and ATI. Jeff has been very much front and centre of the organisation and has huge respect in the industry, and I am sure everyone will be pleased to hear that his appointment has been confirmed.

2023 TRAINING

Apprentice block courses wrapped up at ATI in Christchurch for 2023 with 29 courses provided accomodating 221 Apprentices. Planned courses for the upcoming 2024 year will drop back to 25 courses. While these numbers are still above 2019 pre covid numbers, it is very important that we keep striving as an industry to increase installer numbers.

BPIR - suppliers have been extremely busy putting together compliance information for the Building Product Information Requirments (BPIR) legislation that came in on December 11. Where suppliers/manufacturers provide products for situations that need to comply with any of the six building code clauses, there is a requirement for the relevant information to be made available on their website; whether building consent is needed or not. There is also a requirement for a link to this information source to be available for customers prior to purchase.

Building code - with the review of the building code clauses not yet complete, there is further work to do to keep up with or ahead of future changes. There will be more to come on this in the New Year.
