MEMBERSHIP FEES FOR 2024

The membership fees for 2024 are below. If the membership fee you are invoiced for is incorrect please contact admin@floornz.org.nz as soon as possible.

Membership type:	Annual Membership fee for 2024 (GST exclusive)
Installer	\$250
Supplier	\$550 (Small to medium supplier with less than \$10 million NZ flooring sales revenue p.a.)
	\$1,500 (Large supplier with between \$10-\$30 million NZ flooring sales revenue p.a.)
	\$2,500 (Very large supplier with greater than \$30 million NZ flooring sales revenue p.a.)
Retailer (individual)	\$550 per shop/mobile store not linked to a shop
Retailer (chain/multiple stores)	\$550 first store \$250 each additional store/mobile store not linked to a shop (this membership is charged on one invoice, and is only applicable when all stores are signed up within that retail chain).

If the member is both a supplier and retailer to the market the fee that applies is the greater of the 2 calculations.

- All members will receive a membership pack for each membership fee.
- Large supplier will receive 6 window transfers and 3 copies of the Best Practice Guidelines.
- Very large supplier will receive 12 window transfers and 6 copies of the Best Practice Guidelines.
